Thank you for reporting the above.

I will investigate the matter to decide, firstly, whether there has been any breach of planning control. If there is no breach of planning control, I will not be able to take any action under the provisions of the Town and Country Planning Act. However, I will inform any other departments of the Council or other agencies who may have an interest in the matter.

If there has been a breach of planning control, we will then consider whether any action is justified. To decide that, we will have regard to relevant central Government guidance and council policies and consider whether harm is being caused to the amenity of local residents or to the character of the area.

In any event, I will let you know the outcome when such investigations are concluded. In some cases the investigation can take a long time to be concluded. However, I will let you know about the progress of my investigation within 28 days from the date of this letter.

Helmsdeep, Long Lane

Councillor Sandra Perkins reported the ditch / sewerage issue at Helmsdeep, Long Lane. Update received from Sandra - Hi Nicky, Just had a message to say that the Environment Agency are monitoring the situation with the ditch at Helmsdeep and will be inspecting it again next week. The reference for the case is 1229252 and the officer dealing with it is Rupert Denye tel: 03708 506 506. It may be a good idea to make contact with him on behalf of the Parish Council and that way he would have to keep you informed and up to date, regards Sandra.

Clerk contacted Rupert Denye - he will keep clerk updated directly.

Email received from Robert Denye 6th May - Thank you for your message, I can confirm that I visited the property last week and identified sewage pollution entering the ditch from Helmsdeep. The property has a sewage treatment facility which does not appear to be working properly. I spoke to the occupant of the property and asked her to rectify the situation, she is planning to get a maintenance engineer out to look at her sewage treatment works.

Prepared for the Barnacre-with-Bonds Parish Council meeting, 21st May 2014 I will be writing to the occupant this week to set out our requirements, if the pollution is still ongoing after a reasonable time period has elapsed to allow maintenance work to be done I will take further action.
