

Clerk's Report (For Information Only)

Contacted Linda Anderson at Lancashire County Council to advise that Barnacre Parish Council wish to proceed with the application for Public Right of Way Grant £500 and the biodiversity grant £300 as agreed at the meeting on 11.07.24. Monies received £800 31.07.2024.

16.07.24 Contacted Fiona Reilly at Wyre Council to advise Planning Ambassadors – Cllr Commander and Cllr Harkins, amended website.

16.07.24 Contacted United Utilities via an online contact portal to report the flooding on the access road into Calder Vale. The clerk advised on behalf of the Parish Council that the issue had been discussed at the meeting held on the 11th July 2024 and it was requested that the clerk write to United Utilities to request an inspection/ repair work and advise that this was the only access route into and out of the village. **Works now completed.**

Contact has been made with SS Mary and Michaels Catholic Primary School to book the school hall for the planned Community Event on 09.11.2024. Community Centre on Castle Lane is no longer available for hire. Invites sent to planned organisations to attend.

Email received from SBA team on behalf of PKF Littlejohn – ...have received and logged the notification of exempt status for the year ended 31 March 2024 submitted to us for Barnacre-with-Bonds Parish Council. By notifying us that Barnacre-with-Bonds Parish Council has claimed exemption there is no review to be performed and consequently no auditor certificate and report, or any other closure documentation, will be issued by us for this reporting year.

This concludes the accounts for the year ending 31 March 2024. All documentation will continue to be available for inspection on the Website.

The clerk has sent a Pre application form to the War Memorial Trust regarding potential grant funding for the restoration of Calder Vale War Memorial. Initial timeframe for response given is an assessment period of two months. Application sent 06.08.2024. Contact made with Catforth Parish Council to get feedback regarding their memorial restoration, no reply received yet.

Contact made with the Canal and Rivers trust via email regarding the reported issue of a leaking bridge on the footpath 100 (case ref 1261630 Chris Brooke). Update requested. Email response as follows: -

Further to your email of 2nd September about Wyre Aqueduct our teams are now in the process of scheduling a date for the works to rectify the issue.

Until a start date has been confirmed with all departments involved the local team will continue to monitor the situation closely.
