

Clerk's Report (For Information Only)

Information on The Coronation Living Heritage Fund Grant has been sent to Rebecca Doody (a trustee for Calder Vale cricket field) as requested at the meeting held on 11.09.24 for further discussion at their next meeting.

Emails have been sent to SS Mary & Michael's Catholic Primary School and Calder Vale St John's C of E Primary school to inform them of potential grant funding from the Parish Council to create a biodiversity project for the children. Responses have been received from both schools and they are very keen to be involved and receive the funding to use with this project.

An application has been made to the Champion Grant Scheme for funding to assist with the restoration of the War Memorial in Calder Vale. The application has been passed to the processing officer. Application date 24.09.2024. Grant funding has been agreed and £500 has been received into the Parish Council Bank account on 4/10/2024. Video footage has been sent to Drycraft Stone for quotation and a potential date for work to start if agreed.
