Invitations sent to the 3 churches in the Parish to ring the Bells on 08th May at 6.30PM. All three churches have confirmed bell ringing.

Flag ordered on 07th April at cost of £72.20 including delivery. Chased up delivery 22/04/2025 2 x contact emails sent asking for delivery to be asap. Flag received.

Email sent to Mark Billington at Wyre Council to request confirmation of how the playing field at Bowgreave Rise is registered on the local plan. Email received in reply and sent to all Councillors. Item added to next agenda.

Contacted Elliot Jones regarding the agreed donation for electric bikes. Awaiting invoice from police to be able to make payment.

Contacted Clear Councils insurance and Cas Ltd for Parish Council insurance (£444.93 annual cover only, no long-term agreement) for insurance quotes, renewal costing received for Zurich insurance (renewal quote £324.61 on 3 year long term agreement or £329.26 for annual cover). Quotes to be discussed at meeting and Insurance provider agreed.
